-Fusarium Patch (Fusarium nivale)

Apply 3336 F at 1-2 fl.oz. per 1000 sq.ft. when disease first appears and continue at 7-14 day intervals as needed. Sprays should dry on leaf surfaces with no "watering in". Note: When conditions are unusually favorable for the development of disease, reduce application interval to 5-7 days as needed.

-Pink Snow Mold (Fusarium nivale)

Apply first application of 3336 F at 1-2 fl.oz. per 1000 sq.ft. middle-late November before turf has stoped all growth activity. Lightly water this application into the root zone for best results. A second application may be used in combination with Cleary's Spotrete and PCNB products at reduced rates. Use a spreader-sticker product such as Cleary's Clearspray T/O for best results. Sprays should dry on leaf surfaces with no "watering in".

-Summer Patch (Magnaportha poae)

For prevention, apply 3 applications at 5-10 fl.oz.per 1000 sq.ft. beginning early May using 21 day intervals. -Fusarium Blight (Fusarium roseum and triticum)

-Necrotic Ring Spot (Leptosphaeria korrea)

Apply 3336 F at 5-10 fl.oz. per 1000 sq.ft. when disease first appears and make two applications at 10-14 day intervals as needed. Lightly water this application into the root zone for best results.

-Stripe Smut (Ustillago striiformis)

Apply 3336 F at 5-10 fl.oz. per 1000 sq.ft. when disease first appears making two applications at 14-21 day intervals when disease first appears. Water material into root zone after application with 1/10 -1/4 inch of water. For prevention, apply in spring and fall.

HORTICULTURAL USES (such as Nursery, Greenhouse, Landscape and Interiorscape). ANNUAL AND PERENNIAL FLOWERS, GROUND COVERS, PLUS DECIDUOUS AND EVERGREEN TREES AND SHRUBS.

3336F is a broad spectrum systemic fungicide which controls a variety of foliar, stem, and root diseases on a wide range of commercially important plants. 3336F is also effective as a preplant dip on cuttings and bulbs. Begin applications when disease first appears, or during suspected periods of disease incidence. Apply additional applications every 7-10 days or as otherwise instructed for the prevention or control of the listed diseases. Use of a wetting agent such as Cleary's Super Wet is recommended for plants that have leaves that are difficult to wet properly. Use of a spreader-sticker such as Cleary's Clearspray is recommended to enhance product performance in wet weather conditions. Cleary's 3336 WP may be used to control listed diseases on "backyard" (non-commercial) fruit trees such as almond, apple, apricot, cherry, nectarine, peach, pecan, plum, and prune trees. Maintain continuous agitation to keep the material in suspension and apply with properly calibrated spray equipment.

Application Rates and Timing for Disease Control:

Ground Application (Mechanical or Hand Held): Use 10 - 20 fluid ounces of 3336-F per 100 gallons of water (1/2 -

- -Twig Blights of Juniper(Phomopsis and Kabatina spp. For Phomopsis, apply in spring. For Kabatina, apply late summer. Repeat every 7-10 days as needed during disease period.
- -Septoria Leaf Spot

SOIL DRENCH APPLICATION



Application Rates and Timing for Disease Control: Use 29 fluid ounces of 3336-F per 100 gallons of water. Apply as a drench or heavy spray after transplanting to propagation bed, container, or pot at a rate to thoroughly soak the growing media. A general guide is 1/4 - 2 pints of drench solution per square foot depending on the media type and depth (approximately 8 fl.oz. in a 6 inch pot or 4 fl.oz. in a 4 inch pot). Repeat every 21-28 days to provide adequate crop protection. Note: Application of this product to plug trays or seedlings flats at seeding is not recommended due to potential growth regulating effects.

PREPLANT/DIP TREATMENT-PLANT TYPES AND DISEASES CONTROLLED Application Rates and Timing for Disease Control:

Plants or Cuttings - Use 20 fluid ounces of 3336-F per 100 gallons of water. Immerse plants or cuttings for 10-15

minutes; remove and allow to drain. Wear rubber gloves. 'VEAR CLOTHING OUT LINED IN PPE REQUIREMENTS FOR APPLICATORS AND CTHER HANDLERS. Bulbs - Use 33 fluid ounces of 3336-F per 100 gallons of water, or 2 teaspoonsful of 3736-F per gallon of water.

Soak cleaned bulbs for 15-30 minutes in warm dip (80 to 85 degrees F) preferably within 48 hours of digging. Dry bulbs after treatment. If bulbs are for forcing, treat bulbs that have been heat-cured.

DISEASE(S) CONTROLLED - BULB TREATMENT

Bulb, Corm, and Rhizome Rots

(Botrytis, Fusarium, Gliocladium, Myrothecium, Ramularia, Rhizoctonia, Sclerotinia spp., Thielaviopsis spp., Cylindrocladium spp., Fusarium and Penicillium spp.

CHEMIGATION

Genuric Requirements:

1. Apply this product only through a sprinkler including center pivot, lateral move, end tow, side wheel roll, traveler, solid set, hand move or similar; flood (basin); or drip (trickle) irrigation system. Do not apply this product through any other type of irrigation system.

2. Crop injury, lack of effectiveness, or illegal pesticide residues in the crop can result from non-uniform distribution of treated water.

3. If you have questions about calibration, you should contact State Extension Service specialists, equ:pment manufacturers or other experts.

4. Do not connect an irrigation system (including greenhouse systems) used for pesticide application to a public water system <u>unless</u> the pesticide label-prescribed safety devices for public water systems are in place.

5. A person knowledgeable of the chemigation system and responsible for its operation or under the supervision of the responsible person, shall shut the system down and make necessary adjustments should the need arise.

Specific Requirements:

1. Public water system means a system for the provision to the public of piped water for human consumption if such system has at least 15 service connections or regularly serves an average of at least 25 individuals daily at least 60 ydays out of the year.

²2. Chemigation systems connected to public water systems must contain a functional, reduced-pressure zone(RPZ), backflow preventer or the functional equivalent in the water supply line upstream from the point of pesticide introduction. As an option to the RPZ, the water from the public water system should be discharged into a reservoir tank prior to pesticide introduction. There shall be a complete physical break (air gap) between the outlet end of the fill pipe and the top or overflow rim of the reservoir tank of at least twice the inside diameter of the fill pipe.

3. The pesticide injection pipeline n is contain a functional, automatic, quick-closing check value to prevent the flow of fluid back towards the injection pump.

4. The pesticide injection pipeline must contain a functional, normally closed, solenoid-operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being drawn from the supply tank when the irrigation system is either automatically or manually shut down.

5. The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops, or in cases where there is no water pump, when the water pressure decreases to the point where pesticide distribution is adversely affected.

6. Systems must use a metering pump, such as a positive displacement injection pump or equivalent, effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.

7. Do not apply when wind speed favors drift beyond the area intended for treatment.

APPLICATION INSTRUCTIONS - Hand Held Irrigation:

1. remove scale, pesticide residue, and other foreign matter from the chemical tank and entire injector system. Flush with clean water.

2. Determine the treatment rate as indicated in the directions for use for crop and pathogen and measure the intended areas of application

3. Prepare a suspension of product in the mix tank or stock bucket. Fill the tank with 1/2 or 3/4 of the desired amount of water. Start agitation and add the required amount of product to the solution along with the remaining volume of water.

4. Maintain a gentle agitation in the mix tank during application to assure a uniform suspension.

5. Greater accuracy in calibration and distribution will be achieved by injecting a larger volume of a more dilute suspension per unit time. An injection ration of 1:100 is recommended for greenhouse systems.

INSTRUCTIONS FOR SPRINKLER (OVERHEAD) IRRIGATION

Observe the requirements in the System Requirements section above. Do not apply when wind speed favors drift beyond the area intended for treatment. Apply 3336-F only through systems containing anti-syphon and check valves designed to prevent water source contamination or overflow of the mix tank and containing interlocking controls between the metering device and the water pump to insure simultaneous shut-off. Maintain a gentle continuous agitation in mix tank during mixing and application to assure a uniform suspension. Greater accuracy in calibration and distribution will be achieved by injecting a larger volume of a more dilute suspension per unit time. Application of more than recommended quantities of irrigation water per acre may result in decreased product performance.

Do not apply when wind speed favors drift. When system connections or fittings leak, when nozzles do not provide uniform distribution or when lines containing the product cannot be flushed and must be dismantled and drained in a center pivot system, block the nozzle set nearest the well pivot injection unit to prevent spray being applied to this area. Where sprinkler distribution patterns do not overlap sufficiently, unacceptable disease control may result. Allow sufficient time for pesticides to be flushed through all lines and all nozzles before turning off irrigation water.

3336-F may be applied in conjunction with chemically neutral liquid fertilizers. Application in conjunction with highly alkaline fertilizers, such as aqueous ammonia, may cause a degradation of the pesticide, resulting in reduced performance and should be avoided. Check local restrictions and requirements regarding sprinkler irrigation applications, as they may vary from state to state.

Remove scale, pesticide residues, and other foreign matter from the chemical tank and entire injector system. Flush with clean water. Prepare a suspension of 336-F in a mix tank. Fill the tank with 1/2 to 3/4 of the desired amount of water. Start mechanical or hydraulic agitation. Slowly add the required amount of 3336-F and then the remaining volume of water.

Set sprinkler system to deliver 0.1 to 1.25 inches of water per acre. Volumes of water higher than this may reduce efficacy. Start sprinkler and then uniformly inject the suspension of 3336-F into the irrigation water line so as to deliver the desired rate per acre. The suspension of 3336-F should be injected with a positive displacement pump into the main line ahead of a right angle turn to insure adequate mixing.
