Dear Mr. Baker:

The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance.

Your release for shipment of the product constitutes acceptance of these conditions. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6. Directions for Use

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

- Except when applying to livestock, do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application.
- When used in dairy barns or facilities: close milk bulk tank lids to prevent contamination from spray and from dead or falling insects. Remove or cover milk utensils before application. Wash teats of animals before milking.
- Do not make applications during rain.
- Not for use in metered release systems.

READY TO USE – No dilution necessary, see directions below.

Animal Treatments

Lactating and Non-lactating Dairy Cattle, Beef Cattle, and Calves

Target Insects: Controls Horn Flies

Application: Apply along back and down face. Use 0.1 fl oz (3 mL) per 100 lb (45 kg) of body weight of animal, up to 1 fl oz for any one animal.

Durasect II is to be applied with the squeeze-and-pour bottle provided. To use the squeeze-andpour bottle, remove the cap and inner seal from the calibrated dosing chamber. Estimate the animal's weight and calculate the dose. Squeeze the bottle to fill the dosing chamber to the desired level. Apply product per directions above; do not use product as a spray. Repeat treatment as needed, but no more than once every 2 weeks.

Pesticide Storage and Disposal and Container Handling

Do not contaminate water, food or feed by storage or disposal.

Pesticide Storage: Keep container sealed when not in use. Do not store near food or feed. Pesticide Disposal: Wastes resulting from the use of this product must be disposed of at an approved waste disposal facility.

Container Handling: Non-refillable container. Do not reuse or refill this container. Place in trash or offer for recycling if available or dispose of in a sanitary landfill or by other procedures approved by state and local authorities.

Environmental Hazards

This pesticide is extremely toxic to aquatic organisms, including fish and invertebrates. Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean water mark. Do not apply when weather conditions favor drift from treated areas. Drift and runoff from treated areas may be hazardous to aquatic organisms in neighboring areas. Do not contaminate water when disposing of equipment wash waters.
