For use as a repellent component in the manufacture of oil-base, water-base, pressurized, or aerosol sprays to protect animals from stable flies, horn flies, house flies, horse flies, deer flies, face flies, gnats, and mosquitoes. Not for use in sprays intended for dairy or meat animals or areas in which they are housed.

Sprays, possessing repellent as well as insecticidal properties, are formulated by employing STABILENE in combination with registered insecticides. Registered synergists may be used if desired. When such spray formulations are applied thoroughly and uniformly to the animals, they substantially reduce severe attack by biting and nuisance flies. It is understood that these sprays will be used as an essential part of a complete fly control program which includes the maintenance of cleanliness and sanitation.
