DIRECTIONS FOR USE

Dilute one gallon of EVERCIDE CONCENTRATE 1000C with six gallons of deodorized base oil to make a spray that is effective against accessible stages of confused flour beetles, granary weevils, rice weevils, sawtoothed grain beetles, Angoumois grain moth and Indiana meal moths infesting food storage and manufacturing plants. Apply as a wet spray thoroughly to all surfaces as uniformly as possible, paying particular attention to cracks and crevices, on walls, floors and ceilings. Repeat as often as necessary.

Harmful if swallowed. Cover or remove all food and feedstuffs prior to application. Do not apply while food processing is underway. All food processing surfaces should be covered or thoroughly cleaned before use.
