The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the reregistration of the above referenced product in connection with the pyrethrins, PBO, and MGK-264 REDs, and has concluded that your submission is acceptable.

NOTE: This product is **not** being reregistered under sections 3(c)5 and 4(g) of FIFRA at this time.

Per the product chemistry review dated April 20, 2011, there is no data to show that this product's properties warrants retaining a Physical or Chemical Hazards statement. Therefore, please delete the phrase "Combustible. Do not use or store near heat or open flame" at your next printing of the label.

Please note that the record for this product currently contains the following Confidential Statements of Formulation (CSF), dated July 8, 2010; any previously dated CSFs are superseded:

- Basic CSF, dated July 8, 2010, approved on April 20, 2011.
- Alternate CSF, dated July 16, 2010, approved November 2, 2010.



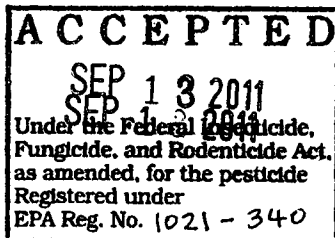
