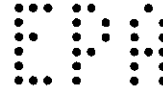

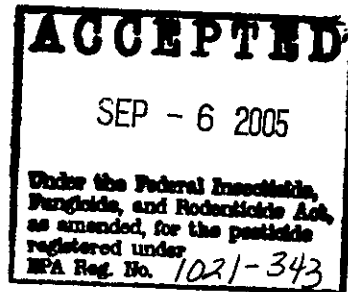

PYROCIDE® INTERMEDIATE 75-OF may be used with suitable emulsifiers as a base for liquid grain protectants, for use in formulating aerosols, for applications in cannery and food processing establishments where the presence of base oil is objectionable because of possible food contamination, for emulsions that are oil-free, for use in fruit fly control, for use in meat packing plants, and for use on growing crops which are about ready to be harvested, where oil may be objectionable, such as lettuce and cole crops.

Mix well in drum before sampling and each use.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Store in a cool, dry place. Keep container closed.
