DIRECTIONS FOR MANUFACTURING USE ONLY

Pack 50 parts of PYROCIDE PRESSURIZED PLANT SPRAY MIX 5101 with 50 parts by wt. of a 50/50 blend of propellents to produce a pressurized product.

CAUTION KEEP OUT OF REACH OF CHILDREN
