MGK® PYROCIDE® Intermediate 5734, EPA Reg. No. 1021-567
Your Submission Dated December 7, 2009**

Dear Ms. Sharp:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable with the following provision(s):

STORAGE AND DISPOSAL section comment(s):

1. Replace the existing "PESTICIDE STORAGE:" subsection with "Keep this product in its tightly closed original container, when not in use. Store in a cool, dry, well-ventilated (preferably locked) area that is inaccessible to children and animals."
2. Replace the existing "CONTAINER HANDLING:" subsection with "CONTAINER DISPOSAL: Nonrefillable container. Do not reuse or refill this container. Triple rinse or pressure rinse container (or equivalent) promptly after emptying.

Triple Rinse as follows [for containers of 5 Gallons (18.9 L) or less]: Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container ¼ full with diluent and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Offer for recycling if available for reconditioning if appropriate, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities.

Triple Rinse as follows [for containers greater than 5 Gallons (18.9 L)]: Empty the remaining contents into application equipment or a mix tank. Fill the container ¼ full with diluent. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Offer for recycling if available for reconditioning if appropriate, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities.

Pressure rinse as follows [for containers greater than 5 Gallons (18.9L) too large to shake]: Empty the remaining contents into application equipment or a mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over application equipment or mix tank or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container, and rinse at about 40 PSI for at least 30 seconds. Drain for 10 seconds after the flow begins to drip. Offer for recycling if available for reconditioning if appropriate, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities."


