

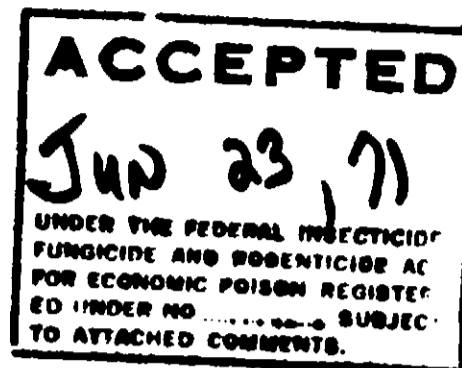

FOR MANUFACTURING USE ONLY

This Intermediate is designed for use at the rate of 4.0% (wt.) with approved solvents, hydrocarbon propellents, and deionized water in the production of pressurized insecticidal sprays.

Note: This Intermediate contains no corrosion inhibitor. Manufacturer is expected to add the approved inhibitor of his choice for final product stability.
