
Dear Ms. Schlekau;

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), is acceptable subject to the comments listed below. Five copies of the finished labeling must be submitted prior to releasing the product for shipment.

1. Revise the Hazards to Humans and Domestic Animals statements as follows:  
"Harmful if swallowed inhaled or absorbed through the skin. Do not get in eyes, on skin, or on clothing. Remove and wash contaminated clothing before reuse, Avoid breathing vapor or spray mist. Causes moderate eye irritation. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, or using tobacco."
