DIRECTIONS FOR MANUFACTURING USE ONLY

Pack 15 parts (wt.) of PYROCIDE AEROSOL MIX 6455 with 85 parts (wt.) of propellents (50/50 ratio of trichloromonofluoromethane and dichlorodifluoromethane) in a pressure dispenser.

This formulation should be stored under as cool conditions as possible, and the contents should be used promptly after the container has been opened. Whenever possible, DDVP formulations should be stored in full containers. Warm contents thoroughly to room temperature and agitate thoroughly before using if this drum has been exposed to below freezing weather. Keep away from open flame. Keep containers tightly closed. Mix well in drum before sampling and each use.

ANTIDOTE: If swallowed, give a tablespoonful of salt in a glass of warm water and repeat until vomit is clear. Have victim lie down and keep him warm and quiet. Call a physician immediately. Atropine is antidotal. 2-PAM is also antidotal and may be administered in conjunction with atropine.

If on the skin wash with large amounts of soap and water. If inhaled remove the victim to fresh air. Keep him warm and quiet. Call a physician immediately.

This product is toxic to fish, wildlife, and birds. Do not contaminate water by cleaning of equipment or disposal of wastes.

Do not reuse empty drum. Return to drum reconditioner or destroy by perforating or crushing and burying in a safe place.
