By Notification we are deleting a sentence referencing technical literature for the product which is no longer available. In addition, we have corrected an omission in the First Aid – If In Eyes section. We have added “or doctor” to the third bullet point in that section.


This notification is consistent with the provisions of PR Notice 98-10 and EPA regulations at 40 CFR 152.46, and no other changes have been made to the labeling or the confidential statement of formula of this product. I understand that it is a violation of 18 U.S.C. Sec. 1001 to willfully make any false statement to EPA. 
