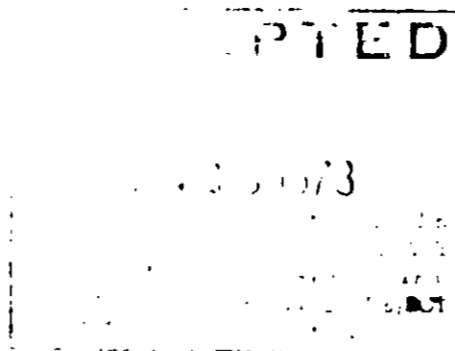

This Intermediate is designed for use where a ratio of 1:3.6 pyrethrins to Tropital Synergist is desired in an insecticidal product.
