The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the reregistration of the referenced product in connection with the **RED for PYRETHRINS**, and have concluded that your submission is acceptable with the following label revision provision(s):

General Comment(s):

1. In order to incorporate required label changes from the acute toxicity review completed for this product, revise all instances of the signal word "**WARNING**" to read "**CAUTION**" throughout the subject label.

First Aid Statement (Table) subsection comment(s):

2. Split the last row within this table into 2 separate rows to read as follows:

NOTE TO PHYSICIAN: Contains petroleum distillate – vomiting may cause aspiration pneumonia. Have the product container or label with you when calling a poison control center or doctor or going for treatment. For information regarding medical emergencies or pesticide incidents, call at 1-888-740-8712.

Precautionary Statements, Hazards to Humans and Domestic Animals subsection comment(s):

3. Revise this subsection to read "Causes moderate eye irritation. Harmful if swallowed, inhaled, or absorbed through skin. Avoid contact with skin, eyes, or on clothing. Avoid breathing vapors. Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals. Wash hands thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco, or using the toilet. Remove and wash contaminated clothing before reuse."

Precautionary Statements, Environmental Hazards subsection comment(s):

4. Revise the 1st sentence to read "This product is highly toxic to aquatic organisms, including fish and invertebrates."

Precautionary Statements, Physical or Chemical Hazards subsection comment(s):

5. Revise this subsection to read "**Flammable**. Keep away from heat and open flame. Contact with strong oxidizers may cause fire and explosions."
