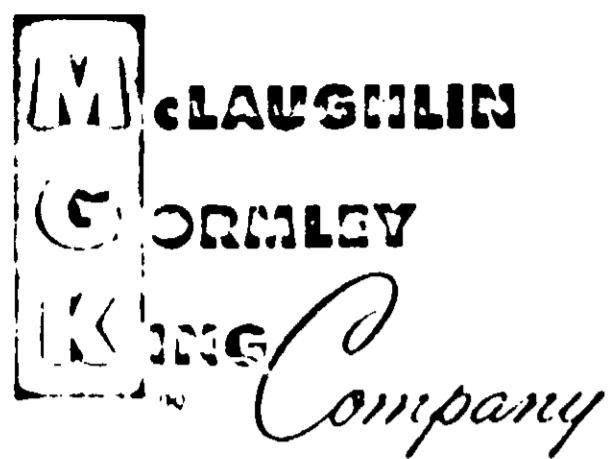

This intermediate is designed for use at the rate of 3.0% (wt.) with approved solvents, deionized water and propellents in the preparation of water-base pressurized insecticidal space sprays.
