DIRECTIONS FOR USE

General: This spray is designed for use undiluted in mechanical sprayers which give particles of aerosol size. It can be diluted with refined kerosenes which meet Food Additive Regulation 121.1182 and can be applied in fogging equipment that gives larger than aerosol particle size.

<u>.PACE SPEAY - Undiluted in Aerosol Generators - to Kill Flies, Mosquitoes, Small</u> <u>Flying Moths and Gnats</u>: Cover or remove opened bags of chicken feed, diet supplements, etc. that could be contaminated by spray. Close windows and doors and shut off air conditioning or ventilating equipment. Apply at the rate of 0.5 ounces of undiluted Concentrate per 1,000 cubic feet of space above the birds. Direct output from aerosol generator upward toward upper corners of room and ceiling./Leave room closed for one half hour. Ventilate room thoroughly before re-entry.

/SPACE SPRAY - Diluted for Ordinary Mechanical Fogging Equipment - to Kill Flies, Mosquitoes, Small Flying Moths and Gnats: Prepare for application as above. Dilute Concentrate with refined kerosene at the rate of 1 part Concentrate plus 49 parts of refined kerosene and mix well. Apply at the rate of 50 fluid ounces dilute spray (0.4 gailons) per 25,000 cubic feet of space above the birds. Direct fog upward toward upper corners of room and ceiling area./Leave room closed for one half hour. Ventilate room thoroughly before re-entry.

CAUTION KEEP OUT OF REACH OF CHILDREN

Harmful if swallowed. Do not apply directly to poultry food or supplements. Do not apply directly to birds.

Do not breathe spray mist.
