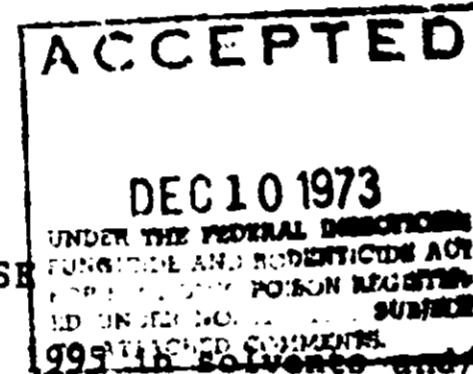

FOR FORMULATION OF INSECTICIDE PRODUCTS ONLY

This Intermediate is designed to be used at the rate of 3.0% (wt.) with approved solvents, deionized water and propellents in the preparation of insecticidal water-base pressurized sprays. Specific gravity = 0.995 (8.26 lbs./gal.).
