The Agency is in receipt of your Application for Pesticide Notification under Pesticide Registration Notice (PRN) 2007-4 dated April 30, 2009 for the product MGK[®] Intermediate 2007 (EPA Registration Number 1021-1290). The Registration Division (RD) has conducted its review of this request for its applicability under PRN 2007-4 and finds that the label changes requested fall within the scope of PRN 2007-4. The label submitted with the application has been stamped "Notification" and will be placed in our records. Per your letter dated 4/30/09, we will also withdraw your earlier PRN 2007-4 notification application for this product submitted on January 23, 2009, as it is replaced by the current Application.

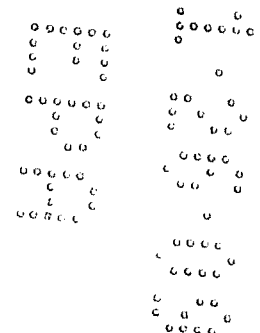

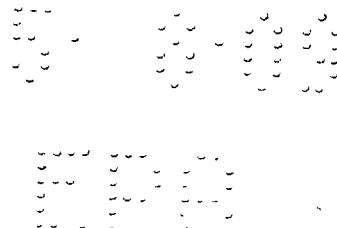
