<u>Genéral</u>: This ready-to-use formula has been specifically designed for use in ULV acrosol generators that produce a large majority of the particles in the 5-30 micron range. A method of determining particle size is available upon request. This product is designed for use in poultry houses, dairy and beef barns, and swine housing areas.

DIRECTIONS FOR USE

For Use In Poultry Houses. Dairy and Beef Barns. Swine Housing: To control house flies, stable flie horn flies. mosquitoes, gnats, small flying moths: Cover or receive exposed food, feedsturfs and watering troughs. Close poultry house or animal barn as tightly as possible. Using a suitable ULV cold aerosol generator, direct spray upward and apply until the room is filled with mist. Vacate premises, keep house closed for 10 to 30 minutes and then wentillate thoroughly prior to re-entry. Repeat application as necessary.

Note: This product will k.11 the above listed insects in the house or barn at the time of treatment. Being non-residual, it will not kill insects that migrate into the treated premises from adjacent areas. In conjunction with space treatment for control of the above mentioned intects, good sanitation measures should be undertaken whenever practical to remove breeding areas and sources for reinvasion of treated premises.
