fo Kill the Accessible Stages of Cigarette Beetle and Tobacco Moth in Tobacco Warehouses:

In Open Warehouses: Use a misting device that will produce a fine mist. Apply undiluted at the rate of 3 ounces per 1,000 cu. ft. of area. Direct spray upward and into all areas of warehouse. Repeat one to three times each week. In severe infestation, daily application can be made, until the insect is brought under control.

<u>In Closed Warehouses</u>: Using either a sprayer that will produce a fine mist, or a ULV cold aerosol generator capable of producing particles ranging from 5-50 microns, apply at the rate of 3 ounces per 1,000 cu. ft. of area. Do not remain in treated area. Leave closed for at least 15 minutes. Ventilate thoroughly prior to re-entry. Repeat as directed under "Open Warehouses".

E: For best results on cigarette beetles, the application should be made, if possible, between 5 p.m. and midnight. This is to coincide with the period of greatest flight activity.
