By Notification we are deleting a sentence referencing technical literature for the product which is no longer available.

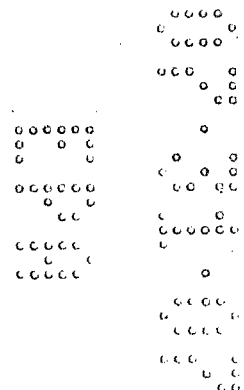
