

For infestations of Azalea, Begonia, Chrysanthemum, Coleus, Fuchsia, Geranium, Ivy, and Petunia.

CONTACT SPRAY For Aphids and Whiteflies: Use 1 pint of this concentrate per 100 gallons of water or 1 teaspoon per gallon. Spray upper and lower surfaces of plant foliage to point of runoff. Spray in late afternoon or at night only. For Whiteflies, repeat application weekly.

When fewer applications are preferred, use 1 quart of this concentrate per 100 gallons of water or 2 teaspoons per gallon. Spray as described above. Repeat as necessary.

For Mealybugs and Spider Mites: Use 2 pints of this concentrate per 100 gallons of water or 2 teaspoons per gallon. Spray upper and lower surfaces of plant foliage to point of runoff. Spray in late afternoon and at night only.

When fewer applications are preferred, use 2 quarts of this concentrate per 100 gallons of water or 4 teaspoons per gallon. Spray as described above. Repeat as necessary.

KILLS COMMON PREMISE PESTS: Cockroaches, Flies, Mosquitoes and other listed on label.

PREMISE PESTS

For use in the home and non-food areas of: Food processing plants, schools, warehouses, theatres, office buildings, industrial plants and kennels.

CONTACT SPRAY - OIL DILUTION: To kill Carpet Beetles, Cockroaches, Confused Flour Beetles, Fleas, Rice Weevils, Saw-toothed Grain Beetles and Ticks. Mix 1 1/3 fluid ounces of this product in a gallon of oil to make a 0.27% spray. Mix well before using. Spray thoroughly into hiding places, such as cracks, crevices, and moist areas around pipes, under refrigerators, and along baseboards. Use at the rate of 1 gallon per 1,000 square feet. Spray directly on insects when possible. Repeat as necessary.

CONTACT SPRAY - WATER DILUTION: This concentrate can also be diluted at the rate of 1 1/3 fluid ounces in a gallon of water and applied as above to kill American and German Cockroaches, Confused Flour Beetles, Fleas, Rice Weevils, Saw-toothed Grain Beetles and Ticks.

SPACE SPRAY: To kill Flies, Gnats, Mosquitoes and Small Flying Moths: Remove or cover exposed food and food handling surfaces including utensils. Remove animals and cover aquariums. Shut off all ventilation systems. Mix 1/2 fluid ounces of this product with 1 gallon water or oil to make an 0.11% spray. Apply as a fine spray at the rate of 2 fluid ounces per 1,000 cubic feet or 1 gallon per 64,000 cubic feet. Mix well before using. Direct spray to upper corners of the room and ceiling. Avoid inhalation of spray mist. Vacate room and keep closed for at least one half hour. Ventilate room before re-entry. Repeat as necessary.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Store in a cool, dry place. Keep container closed.

CONTAINER DISPOSAL: Triple rinse (or equivalent) and offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill or by other approved State and Local procedures.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.
