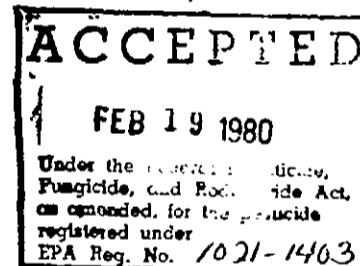

Warm to room temperature. Mix well in drum before sampling and each use.
