The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. One copy of the finished labeling must be submitted prior to releasing the product for shipment.

Add to the directions for use the following statements, which are on the source product label:

Only for formulation into an insecticide for the following uses: space spray, fogger, crack & crevice spray, outdoor fogging spray, residual spray, direct spray, and wasp & hornet spray.

In lieu of the statement "Formulators who use this product may be responsible for providing data to support their own registrations with the appropriate regulatory agencies," use one of the following statements from PR Notice 94-1:

"This product may be used to formulate products for specific use(s) not listed on the manufacturing product label if the formulator, user group or grower has complied with U.S. EPA data submission requirements regarding the support of such uses(s)." or

"This product may be used to formulate products for any additional uses not listed on the manufacturing product label if the formulator, user group, or grower has complied with U.S. EPA data submission requirements regarding the support of such uses."

The If Swallowed First Aid statement must read as follows for products containing petroleum distillates in any amount:

If swallowed: Immediately call a poison control center or doctor. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.


