The proposed amendment to the registration of the product cited above under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, revising the label in accordance with PR Notice 2001-1 is acceptable subject to the comment listed below:

A First Aid statement for If In Eyes must appear on the label to read as follows:

If In Eyes: \*Hold eye open and rinse slowly and gently with water for 15-20 minutes.  
\*Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye.  
\*Call a poison control center or doctor for treatment advice.


This statement was removed from the label submitted on May 3, 2004. The Agency inadvertently accepted this label. This product was originally accepted under the Cite-All provision and the label contained the statement, "Avoid contact with skin and eyes.". Therefore, the label must contain the First Aid statement for If In Eyes.
