The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable subject to the comments listed below. Stamped copies of the labeling is enclosed for your records.

1. Please change the statement "Causes eye irritation" to read "Causes moderate eye irritation." Delete the statement "'Do not get in eyes" and revise the following statement to read "Avoid contact with skin, eyes, and clothing."
2. Please revise the second statement under your "IF SWALLOWED" section of the Statement of Practical Treatment section to read: Do not induce vomiting. Do not give anything by mouth to an unconscious person. Avoid alcohol".
3. Under your "Physical and Chemical Hazards" section, add the word "Combustible" in front of the "Do not use or store..." statement.
