The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable with the following provision(s):

Ingredient Statement section comment(s), page 1 of 9:

Revise to read as follows:

ACTIVE INGREDIENT:

Piperonyl Butoxide, Technical*	91.30%
OTHER INGREDIENTS	8.70%
Total	100.00%

First Aid section comment(s), page 1 of 9:

Revise the last statement in the table to read as follows:

"Have the product container or label with you when calling a poison control center or doctor, or going for treatment. For additional information on this pesticide product (including health concerns, medical emergencies or pesticide incidents), you may call 1-888-740-8712 or the National Pesticide Information Center at 1-800-858-7378." ¹

<u>Precautionary Statements section, Personal Protective Equipment subsection comment(s), page 1 of 9:</u>

3. On the 1st bulleted statement, replace the misspelled word "filer" with "filter."

Precautionary Statements section, User Safety Requirements subsection comment(s), page 1 of 9:

4. In the 2nd sentence, insert the word "exist" immediately following the word "washables."

Precautionary Statements section, User Safety Recommendations subsection comment(s), page 2 of 9:

5. In the 1st bulleted statement, insert the words "with plenty of soap and water" immediately following the word "hands."

Precaulionary Statements section. Environmental Hazards subsection comment(s), page 2 of 9:

- 7. In the 2nd sentence of the 3rd paragraph, insert the word "local" immediately preceding the word "sewage."

Agricultural Use Requirements text box comment(s), page 2 of 9:

8. Revise the statement starting with "PPE required for early entry..." by inserting the word "the" immediately preceding the word "Worker."

General Use Requirements and Use Restrictions section comment(s), page 2 of 9:

9. Delete all text following the "Non-Agricultural Use Requirements" text box and insert a new section labeled as "General Precautions and Use Restrictions" as follows:

"GENERAL PRECAUTIONS AND USE RESTRICTIONS

This product is an emulsifiable concentrate for use in a tank mix with insecticides and acaricides to aid in improving the control of insects and mites. MGK[®] PBO-8E is a synergist that aids in blocking oxidative resistance that may develop in insects and mites that has no insecticidal properties of its own.

Do not apply this product in a way that will contact adults, children, or pets, either directly or indirectly through drift. Only protected handlers may be in the area during application.

Do not wet plants to point of runoff or drip.

Do not use treated article before it is dry.

Do not apply directly to or near water, storm drains, or drainage ditches. Do not apply when windy. To prevent product run-off, do not over water the treated area(s) or apply when heavy rain is expected. Rinse applicator over lawn or garden area only.

Application Types:

MGK® PBO-8E may be applied via ground application units, hand-held sprayers, power sprayers, Foggers and ULV applicators, and chemiqation.

For Use on Crops section, Spray Drift Management for Agricultural Crops subsection comment(s), page 3 of 9:

10. As per the piperonyl butoxide RED ², insert the following statements immediately following the 2nd paragraph as follows:

"Do not release spray at a height greater than 10 feet above the ground or crop canopy."

The boom length must not exceed 75% of the wingspan or 90% of the rotor blade diameter.

Aerial applicators must consider flight speed and nozzle orientation in determining droplet size.

When applications are made with a cross-wind, the swath will be displaced downwind. The applicator must compensate for this displacement at the downwind edge of the application area by adjusting the path of the aircraft upwind."

Crop Use Rates and Restrictions section comment(s), page 4 of 9:

11. In the table titled as "Food Crops Grown Outdoors or in Greenhouses in Agricultural Settings," replace the 5th bullet on the right side of the table with "A 10-day water hold is required for all pyrethrins applications when rice fields are flooded."

Non-Crop Use Directions section, Residential Dwellings and Commercial, Institutional Indoor Sites subsection comment(s), page 6 of 9:

12. As per the piperonyl butoxide RED ³, insert the following statement immediately following the existing statement starting with "If used as a crack and crevice, ..." as follows: "For metered release device space sprays, do not exceed 0.80 oz. of MGK[®] PBO-8E per 1000 cu. ft. of space treated per day."

<u>Post Harvest Application to Vegetables, Fruits, Nuts, and Other Commodities section comment(s), page 6 of 9:</u>

- 13. Revise the statement starting with "When used as a space spray to fruits, ...," by replacing the number "10000" with "1000."
- 14. As per the piperonyl butoxide RED 4 , insert the following statement immediately following the existing statement starting with "When used as a surface application to the commodities listed, ..." as follows: "When used as a surface application to fruits or tomatoes in baskets or hampers, do not exceed 1.3 x 10^{-5} oz. of MGK® PBO-8E per lb. of fruit."

<u>Direct Application to Livestock, Dairy and Poultry Animals section comment(s), page 7 of 9:</u>

- 15. In the 1st sentence, insert the word "to" immediately following the word "directly."
- 16. As per the piperonyl butoxide RED ⁵, insert the following statement at the end of this section as follows: "Do not apply microencapsulated product to lactating or food animals."

When Animals Are Not Present section comment(s), page 7 of 9:

17. As per the piperonyl butoxide RED ⁶, insert the following statement immediately following the existing statement starting with "For surface applications, ..." as follows: "For metered release device space sprays, do not exceed 0.80 oz. of MGK[®] PBO-8E per 1000 cu. ft. of space treated per day."

As A Space Spray When Animals Are Present section comment(s), page 7 of 9:

18. In the 2nd sentence, replace the number "10000" with "1000."

Outdoor Agricultural Premises section comment(s), page 7 of 9:

19. As per the piperonyl butoxide RED ⁷, replace the existing statement starting with "For crack and crevice, ..." with the following: "For crack and crevice, or spot surface sprays (including applications for fire ant applications or turf diagnostic aid), do not exceed 8.0 fl. oz. of MGK® PBO-8E per 1000 sq. ft. of space treated."

20. Replace this section with the following:

"STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Pesticide Storage: Keep this product dry in a tightly closed container, when not in use. Store in a cool, dry, well-ventilated area away from heat or open flames.

Pesticide Disposal: Waste resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

Container Disposal: Triple rinse (or equivalent). Then offer for recycling and reconditioning, or puncture and dispose of container in a sanitary landfill, or by other procedures approved by state and local authorities." ⁸

MGK Company should note that a notice of availability of EPA's RED for products containing piperonyl butoxide was published in the *Federal Register* on July 26, 2006 (Volume 71, Number 143, Pages 42385-42386). As a result, additional data and/or labeling changes may be required for products containing piperonyl butoxide.

Please submit two (2) copies of the final printed labeling, incorporating the above changes, before releasing the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). SPRAY DRIFT MANAGEMENT FOR AGRICULTURE CROPS:

Avoiding spray drift at the application site is the responsibility of the applicator and the grower. The interactions of many equipment and weather-related factors determine the potential for spray drift. The applicator and the grower are responsible for considering all these factors when making decisions.
