PREMISE PESTS

MIX WELL BEFORE USE

For use in the home and non-food areas of: food processing plants, schools, warehouses, theatres, office buildings, kennels, etc.

Contact Spray - Oil or Water Dilution: To kill cockroaches, crickets, saw-toothed grain beetles, sowbugs, centipedes, carpet beetles, confused flour beetles, ticks, fleas, and rice weevils: Mix two (2) fluid ounces of EVERCIDE® Concentrate 2363 in one gallon of oil or water to make a 0.20% spray. Mix well before using. Spray thoroughly into hiding places, such as cracks, crevices, and moist areas around pipes, under refrigerators, and along baseboards. Use at the rate of one (1) gallon per 1,000 square feet. Spray directly on insects when possible. Repeat as necessary.

STORAGE AND DISPOSAL

Storage: Store in a cool, dry place. Keep container closed.

Pesticide Disposal: Pesticide, spray mixture or rinse water that cannot be used according to label instructions must be disposed of according to applicable Federal, State or Local procedures.

Container Disposal: Triple rinse (or equivalent) and offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by other approved State and Local procedures.
