Dear: Ms. Schlekau:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable subject to the comments listed below. Stamped copies of the labeling is enclosed for your records.

- 1. Under the Precautionary Statements section, after the phrase "Causes...injury", add the following statements: "Do not get in eyes or on clothing. Wear protective eyewear (goggles, face shield, or safety glass). Harmful if inhaled."
2. Change your Statement of Practical Treatment statement for IF IN EYES to read: "Hold eyelids open and flush with a steady, gentle stream of water for 15 minutes. Get medical attention."
3. Please revise the second statement under your "IF SWALLOWED" section of the Statement of Practical Treatment section to read: "Do not induce vomiting. Do not give anything by mouth to an unconscious person. Avoid alcohol".
4. Delete the word "warm" from the statement "Wash skin...water."
5. Under your "Physical and Chemical Hazards" section, add the word "Combustible" in front of the "Do not use or store..."
