NOTE: This product is not being reregistered under sections 3(c)5 and 4(g) of FIFRA at this time.

Please be reminded that 40 CFR Part 156.140(a)(4) requires that a batch code, lot number, or other code identifying the batch of the pesticide distributed and sold be placed on non-refillable containers. The code may appear either on the label or durably marked on the container itself, and can be added by non-notification per PRN 98-10.



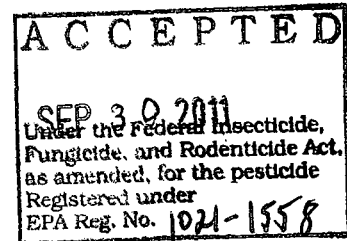

**Vacate the treated house, individual apartment unit or other structure immediately.** Keep treated area closed for two (2) hours. Do not remain in the area during treatment.

**Do not Re-enter for 2 hours**

**Airing Out:** Wait two (2) hours after application, then open windows, vents and doors for two (2) hours. If an odor is still detectable, additional ventilation is required

**To Kill Fleas and Ticks:** Destroy pet's old bedding and replace with fresh bedding. Use product as directed above. Treat dogs and cats with registered tick control product prior to re-entry.
