

Keep room closed for 15 minutes after spraying. Sweep up and discard fallen insects. Before spraying, cover exposed food and utensils.

TO KILL FLEAS AND TICKS IN PET BEDDING AND PET AREAS: Remove and destroy pet's old bedding. To reduce infestation, thoroughly spray the animal's bedding, sleeping quarters, around baseboards, window and door frames, wall cracks, local areas of floors, and other resting places until the surface is slightly moist. Treat these areas at the rate of two seconds per linear foot at a distance of 12 to 18 inches. Also, spray the entire inside surface of doghouses. Repeat as necessary. Put fresh bedding in pet's quarters after spray has dried. **DO NOT SPRAY ANIMALS.** Also treat dogs and cats with a registered flea and tick control product before allowing them to re-enter treated area.
