The amendment referred to above, submitted in connection with registration under FIFRA sec. 3(c)(7)(A), is acceptable provided that you:

1. Submit and/or cite all data or other material required for registration/reregistration of your product under FIFRA sec. 3(c)(5) or FIFRA sec. 4 when the Agency requires all registrants of similar products to submit such data.

2. Make the labeling changes listed below before you release the product for shipment:

a. Based on the last acute toxicity review of this product, revise the precautionary statements and the statement of practical treatment as follows:

Do not use on nursing puppies or kittens under 3 months of age. Do not use this or any other pesticide on sick, old or debilitated pets. Do not spray plants used for food or feed.

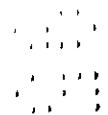
FOR PETS

This product will kill fleas up to 14 days on dogs and cats and will kill ticks for 4 days on dogs and 9 days on cats.

Spray the animal from a distance of 8-12 inches. Start spraying at the tail, moving the dispenser rapidly and making sure the animal's entire body is covered, including the legs and under the body. Using a protective mitt or glove, fluff the hair as you spray so the spray will penetrate to the skin. The spray should wet the ticks thoroughly. FOR PETS

This product will kill fleas up to 14 days on dogs and cats and will kill ticks for 4 days on dogs and 9 days on cats.

Pet Areas: Remove and launder pet bedding. While bedding is removed, spray infested areas around pet bed and other pet resting areas. Spray baseboards, cracks and crevices, and spot treat carpets, rugs, or other areas where these pests may be found. Repeat as necessary.

FOR PLANTS

For use on Indoor Houseplants, such as African Violet, Dieffenbachia, Gold-Brocade Plant, Ivy, Madame Butterfly, Philodendron, Purple Passion, Schefflera and Silver Tree Plant. Certain indoor houseplants may be sensitive to burning of foliage or dropping of leaves. Before treating any plant, test by spraying one to two leaves and checking for damage.

This product kills Aphids, Mealybugs, Whiteflies and Spider mites and provides up to two (2) weeks of control. ✓

Spray both upper and lower leaf surfaces from a distance of 10-12 inches until visibly wet. Repeat as needed.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Store in a cool dry area away from heat or open flame.

DISPOSAL: Replace cap and discard container in trash. Do not incinerate or puncture.
