Dip animal into solution, making sure hair is wet to the skin. The area around the ears should be sponged thoroughly. Avoid contact of material with eyes and mouth of animal. Do not rinse off. Repeat as necessary for control.

STORAGE AND DISPOSAL

STORAGE: Store in a cool, dry place. Keep container closed.

DISPOSAL: Do not reuse empty container. Wrap container in several layers of newspaper and discard in trash.
