The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable, subject to the comments listed below.

- 1. Under the "Precautionary Statements" section, please move the statements "Do not use in food areas...when in use." to the "Directions for Use" section of your label.
- 2. Revise the "Precautionary Statements" section to read "Harmful if swallowed, absorbed through the skin, or inhaled. Avoid contact with skin, eyes, or clothing. Avoid breathing vapor or spray mist. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse."
- 3. Revise the statement "Spray surfaces until wet" to read "Spray surfaces until wet but not to the point of runoff."
- 4. Under "To Kill Brown Dog Ticks and Fleas", add the following sentences to the end of the paragraph: "To control the source of flea infestations, treat your pet with a product registered for animal application. Also, treat your yard with a product registered for yard application.
- 5. Add the following statements after the sentence "Do not apply in classrooms when in use": "Do not apply this product in occupied patient rooms or in any rooms/areas while occupied by patients, the elderly or infirm. Do not apply to institutions (including libraries, sports facilities, etc.,) in the immediate area when occupants are present."
