The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide.Act, as amended, is acceptable subject to the comments listed below. Two (2) copies of the finished labeling must be submitted prior to releasing the product for shipment. A stamped copy of the label is enclosed for your records.

1. Add "Contains Petroleum Distillates" under the Ingredients Section on the label.

- 2. Since the product contains petroleum distillates, revise the first sentence in the Precautionary Statements to read: "Harmful if swallowed or absorbed through skin."
- 3. As requested in your May 25, 2005 amendment, add "Drift and runoff may be hazardous to aquatic organisms in water adjacent to treated areas." to Environmental Hazards Section.

#### PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

## CAUTION

Harmful If absorbed through skin. Avoid contact with skin, eyes, or clothing. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, or using tobacco. Remove and wash contaminated clothing before reuse.

#### ENVIRONMENTAL HAZARDS

This pesticide is toxic to fish and other aquatic organisms. Do not apply directly to water. Do not contaminate water when disposing of equipment wash waters or rinsate.

#### PHYSICAL OR CHEMICAL HAZARDS

Contents under pressure. Do not use or store near heat or open flame. Do not puncture or incinerate container. Exposure to temperatures above 130°F may cause bursting.

#### **DIRECTIONS FOR USE**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Do not use in commercial food processing, preparation, or food storage or serving areas. In the home, all food processing surfaces and utensils should be covered during treatment, or thoroughly washed before use. Exposed food should be covered or removed. Non-food areas are areas such as garbage rooms, lavatories, floor drains (to sewers), entries and vestibules, offices, locker rooms, machine rooms, boiler rooms, garages, mop closets, and storage areas (after canning or bottling).

Remove pets and birds and cover fish aquariums before spraying.

Do not allow children or pets to contact treated surfaces until spray has dried.

Do not apply to classrooms when in use.

Do not apply this product in occupied patient rooms or in any rooms/areas while occupied by patients, the elderly or infirm. Do not apply to institutions (including libraries, sports facilities, etc.) in the immediate area when occupants are present.

#### SHAKE WELL BEFORE USE

<u>General</u>: Use this spray as a spot or crack and crevice treatment to control Cockroaches, Fleas, Silverfish, Ticks, Waterbugs, and other insects listed below. Apply this product only as a coarse spray or crack and crevice treatment to localized areas where pests are found or may occur. Spray surfaces until wet but not to the point of runoff.

#### FOR SPOT TREATMENT:

<u>To Kill Ants, Cockroaches, Crickets, Silverfish, Spiders, Sowbugs, and Carpet Beetles</u>: Spray areas where these insects are found or may hide, including dark corners of rooms and closets; cracks and crevices in walls; along baseboards and door and window frames; behind and beneath sinks, stoves, refrigerators, and cabinets; and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. For ants, apply to ant trails, also around doors and windows and wherever else these pests may find entrance.

<u>To Kill Brown Dog Ticks and Fleas</u>: Thoroughly apply as a spot treatment to infested areas such as pet beds and resting quarters; nearby cracks and crevices; along and behind baseboards, window and door frames; and localized areas of floor and floor coverings where these pests may be present. Old bedding should be removed and replaced with clean, fresh bedding after treatment. DO NOT SPRAY PETS WITH THIS PRODUCT. To control the source of flea infestations, treat your pet with a product registered for animal application. Also, treat your yard with a product registered for yard application.

#### FOR CRACK AND CREVICE:

To Kill Ants, Cockroaches, Crickets, Silverfish, Sowbugs, Spiders, Brown Dog Ticks, Fleas, and Carpet Beetles: Apply spray in small amounts directly into cracks and crevices; in points Setween different elements of construction; between equipment, floors, and openings leading to voids; into hollow spaces in walls; and on equipment legs and bases where the above listed insects hide.

Take care to avoid depositing the product onto exposed surfaces or introducing the material into the air. Avoid contamination of food or food processing surfaces.

<u>Flies and Mosquitoes</u>: Use only outdoors as an aid in reducing annoyance from these insects. Spray outside surfaces of window and door frames as well as other areas where these pests may enter the home. Also spray dark corners and localized resting areas (such as under eaves) or porches, patios, and garages where these insects may congregate. Flies and mosquitoes coming to rest on treated surface will be killed.

#### STORAGE AND DISPOSAL

STORAGE: Store in a cool, dry place. Keep container closed.

Do not puncture or incinerate! If empty: Place in trash or offer for recycling if available. If partly filled: Call your local solid waste agency or 1-800-CLEANUP for disposal Instructions.
