
Dear Ms. Schlekau:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable, subject to the comments listed below.

1. Under the "Precautionary Statements" section, please move the statements "Avoid contamination of food or feedstuffs. Do not use in food areas...when in use." to the "Directions for Use" section of your label.
2. The acute toxicity profile for this product indicates it is in Toxicity Category IV for all exposure routes. Therefore, a First Aid statement is not required. You may also delete the signal word "Caution" as well as the statements "Hazards to Humans and Domestic Animals, Harmful if swallowed...etc., Do not breathe vapor ...etc., Avoid contact...etc., In case of contact...etc., ...and obtain medical attention."
3. Revise the statement "Spray surfaces until wet" to read "Spray surfaces until wet but not to the point of runoff."
4. Under "To Kill Brown Dog Ticks and Fleas", add the following sentences to the end of the paragraph: "To control the source of flea infestations, treat your pet with a product registered for animal application. Also, treat your yard with a product registered for yard application."
5. Add the following statements after the sentence "Do not apply in classrooms when in use": "Do not apply this product in occupied patient rooms or in any rooms/areas while occupied by patients, the elderly or infirm. Do not apply to institutions (including libraries, sports facilities, etc.) in the immediate area when occupants are present."

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION

Harmful if swallowed or absorbed through skin. Do not breathe vapors or spray mist. Avoid contact with skin or eyes. In case of contact, flush with plenty of water. Wash with soap and water after use. Obtain medical attention if irritation persists. Avoid contamination of food or feedstuffs.

Do not use in food areas of food handling establishments, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed or facility is in operation. Serving areas are areas where prepared foods are served such as dining rooms, but excluding areas where foods may be prepared or held. In the home, all food processing surfaces and utensils should be covered during treatment or thoroughly washed before use. Exposed food should be covered or removed. Non-food areas are areas such as garbage rooms, lavatories, floor drains (to sewers), entries and vestibules, offices, locker rooms, machine rooms, boiler rooms, garages, mop closets and storage (after canning or bottling).

Remove pets, birds, and cover fish aquariums before spraying.

Do not allow children or pets to contact treated surfaces until spray has dried.

PHYSICAL OR CHEMICAL HAZARDS

Contents under pressure. Keep away from heat, sparks and open flame. Do not puncture or incinerate container. Exposure to temperatures above 130 F may cause bursting.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

SHAKE WELL BEFORE USE

For Spot/Crack and Crevice Treatment Only. Do Not Use As A Space Spray.

General: Use this spray as a spot or crack and crevice treatment to control cockroaches, fleas, silverfish, ticks, waterbugs and other insects listed below. Apply this product only as a coarse spray or crack and crevice treatment to localized areas where pests are found or may occur. Spray surfaces until wet.

FOR SPOT TREATMENT

To Kill Ants, Cockroaches, Crickets, Silverfish, Spiders, Sowbugs and Carpet Beetles: Spray areas where these pests are found or may hide, including dark corners of rooms and closets; cracks and crevices in walls; along baseboards and door and window frames; behind and beneath sinks, stoves, refrigerators and cabinets and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. For ants, apply to ant trails, also around doors and windows and wherever else these pests may find entrance.

To Kill Brown Dog Ticks and Fleas: Thoroughly apply as a spot treatment to infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames and localized areas of floor and floor coverings where these pests may be present. Old bedding should be removed and replaced with clean, fresh bedding after treatment. **DO NOT SPRAY PETS WITH THIS PRODUCT.**

Flies, Spiders and Mosquitoes: Use only out of doors as an aid in reducing annoyance from these insects. Spray outside surfaces of window and door frames as well as other areas where these pests may enter the home. Also spray dark corners and localized resting areas (such as under eaves) or porches, patios and garages where these insects may congregate. Flies and mosquitoes coming to rest on treated surface will be killed.

FOR CRACK AND CREVICE

To Kill Ants, Cockroaches, Crickets, Silverfish, Sowbugs, Spiders, Brown Dog Ticks, Fleas and Carpet Beetles: Apply spray in small amounts directly into cracks and crevices. [Use extension tube to] Deliver a pin stream between different elements of construction, between equipment and floors, openings leading to voids and hollow spaces in walls, equipment legs and bases where insects hide.

Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air.

STORAGE AND DISPOSAL

STORAGE: Store in a cool, dry place. Keep container closed. Do Not Puncture or Incinerate!

DISPOSAL:

If Empty: Do not reuse this container. Place in trash or offer for recycling if available.
If Partly Filled: Call your local solid waste agency or 1-800-CLEANUP for disposal instructions. Never place unused product down any indoor or outdoor drain.
