

By Notification, we are updating the storage and disposal statement per PR-Notice 2004-7. This product is an undilutable manufacturing use product, therefore we have not added detailed rinsing instructions per §156.146. We have however, per Nancy Fitz' recommendation maintained our current instructions to triple rinse the container before disposing of it.
