

By Notification, we are updating the storage and disposal statement per PR-Notice 2004-7. We have however, per Nancy Fitz' recommendation maintained our current instructions to triple rinse the container before disposing or offering for reconditioning or recycling. Enclosed are two (2) copies of the label. One (1) copy has changes highlighted.

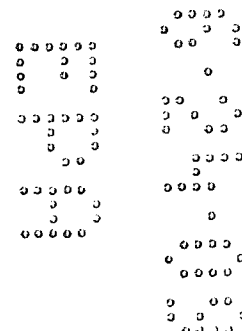
