Dear Ms. Schlekau:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable, subject to the comments listed below.

- 1. Under the "Precautionary Statements" section, please move the statements "Avoid contamination of food or feedstuffs. Remove pets, birds, and cover fish aquariums before spraying" to the "Directions for Use" section of your label.
- 2. Under the "To Kill Ticks and Fleas" section, add the following sentence to the end of the paragraph: "Also, treat your yard with a product registered for yard application."
- 3. You may delete the If Swallowed first aid and the Harmful if swallowed statement since the acute oral toxicity is in toxicity category IV. Based on the amount of petroleum distillates in the product you may also delete this statement under ingredient statement and Note to Physician.
- 4. Revise the first sentence under Precautionary Statements to read, "Harmful if inhaled or absorbed through the skin. Causes moderate eye irritation."

X 5 ft. or smaller; instead, allow fog to enter from other rooms. *Turn off ALL ignition sources such as pilot lights (shut off gas valves), other open flames or running electrical appliances that cycle off and on (i.e., refrigerators, thermostats, etc.).* Call your gas utility or management company if you need assistance with your pilot lights.

Do not apply when food processing facility is in operation or foods are exposed. Cover or remove all food and food processing equipment before application. Leave building at once and keep building closed for two hours before airing out. Open all doors and windows and allow to air for 30 minutes. Repeat spraying in two weeks.

<u>To Kill Ticks and Fleas</u>: Destroy pet's old bedding and replace with clean, fresh bedding after treatment is completed. Use product as above. Pets should be treated with a registered flea and tick control product prior to reentering treated premises.
