## CAUTION

This product is designed to be tank mixed with non-synergized contact or residual insecticides for use in mosquito adulticides as well as food and non-food areas of food handling, food processing, food preparation, food product storage, transportation, and bottling facilities, including Federally inspected meat and poultry plants and non-Federally inspected facilities.

Observe all directions on the insecticide product label as well as this label. For crop use and as a mosquito adulticide, tank mix Piperonyl Butoxide OS for a maximum application rate of 0.021 lb. a.i. per acre. For other uses, tank mix with a maximum of twice the amount of pyrethroid insecticide in the spray mixture (1 part pyrethroid to 2 parts Piperonyl Butoxide OS). Always apply in accordance with the more restrictive of label limitations and precautions. Do not exceed any label dosage rates. This product cannot be mixed with any product with label prohibitions against such mixing.
