

Enclosed are 2 copies of the label. One copy has changes highlighted.

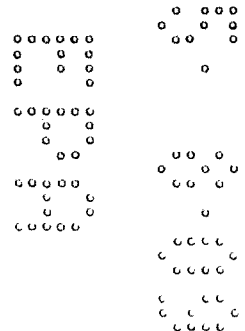
