HAZARDS TO HUMANS AND DOMESTIC ANIMALS

Harmful if absorbed through skin or inhaled. Avoid contact with skin or clothing and inhaling spray mist. Wash thoroughly after handling. Remove contaminated clothing and wash before reuse.

SHAKE WELL BEFORE USE

This product will kill ants, cockroaches, confused flour beetles, crickets, fleas, houseflies, mosquitoes, rice weevils, saw-toothed grain beetles, small flying moths, sow bugs, spiders and ticks.

DO NOT use more than one fogger per room. DO NOT use in small, enclosed spaces such as closets, cabinets or under counters or tables. Do not use in a room 5 ft. X 5 ft. or smaller; instead, allow fog to enter from other rooms. Turn off ALL ignition sources such as pilot lights (shut off gas valves), other open flames or running electrical appliances that cycle off and on (i.e., refrigerators, thermostats, etc.). Call your gas utility or management company if you need assistance with your pilot lights.

KEEP CONTAINER UPRIGHT

Cover exposed food, dishes and food-handling equipment. Open cabinets and doors to area to be treated. Shut off fans and air conditioners. Close doors and windows. Point valve opening away from face when releasing. Use one unit for each [5,000] 6,000 cubic feet of unobstructed area. Do not remain in the area during treatment and ventilate thoroughly before re-entry.

TO OPERATE VALVE: Place several layers of newspaper or pad on stand or on table in the center of the room. Point valve opening away from face. To lock valve in open position for automatic discharge, press valve button all the way down, hooking the catch. Then place fogger on stand or table in the center of the room with valve locked open. Leave building at once and keep building closed for two hours before airing out. Open all doors and windows and allow to air for 30 minutes. Repeat spraying in two weeks or when necessary.

To Kill Ticks and Fleas: Destroy pet's old bedding and replace with clean, fresh bedding after treatment is completed. Use product as above. Pets should be treated with a registered flea and tick control product prior to reentering treated premises.

STORAGE AND DISPOSAL

STORAGE: Store in a cool dry area away from heat or open flame.

DISPOSAL: Replace cap and discard container in trash. Do not incinerate or puncture.

DISPOSAL: This container may be recycled in aerosol recycling centers. At present, there are only a few such centers in the country. Before offering for recycling, empty the can by using the product according to the label (DO NOT PUNCTURE!). If recycling is not available, wrap the container and discard in the trash.
