All outdoor applications must be limited to spot or crack-and-crevice and wasp and hornet nest treatments only.

All outdoor applications to impervious surfaces such as sidewalks, driveways, patios, porches and structural surfaces (such as windows, doors, and eaves) are limited to spot and crack-and-crevice applications, only.

<u>For Control of Nests of Wasps, Yellow Jackets and Hornets</u>: The best time to spray the nest is in the early morning or early evening when the air temperature is cooler, most insects are in the nest, and little activity is observed around the nest opening. Spray only if the air is still. Stand at a safe distance from the nest. Do not stand directly under the nest. Hold container upright at arms length and point the actuator at the nest. First spray the opening of the nest. Then spray the rest of the nest until it is saturated. Treated insects may fall out of the nest and die. Any insects returning to the nest after treatment will be killed. Wait 48 hours before removing the nest. Hose off foliage of desirable plants contacted with spray.

For scorpions, stand 3-4 feet away and thoroughly cover the insect. Make sure scorpions are dead before removing.

This product may stain or adversely affect vinyl, painted, and plastic surfaces. Avoid application to asphalt roofing shingles as staining may occur. Test in an inconspicuous area and re-check in a few hours before using in areas where spray may contact these surfaces.

#### STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage and disposal.

#### Pesticide Storage

Store in a cool dry area. Always store pesticides in the original container. Store away from food and pet food.
