TO OPERATE VALVE: To lock valve in open position for automatic discharge, press valve button all the way down, hooking the catch. Then place fogger on stand or table in the center of the room with valve locked open, placing several layers of newspaper or pad under fogger. Leave building at once and keep building closed for two hours before airing out. Open all doors and windows and allow to air for one-half hour. Repeat spraying in two weeks or when necessary.

To Kill Ticks and Fleas: Destroy pet's old bedding and replace. Use product as above. Pets should be treated with a registered tick and flea control product prior to reentry. Repeat as necessary to bring infestation under control.

Do not use this unit in a cabinet or under a counter or table. Do not use this unit in an area less than 100 cubic feet.

**STORAGE AND DISPOSAL**

STORAGE: Store in a cool dry area away from heat or open flame.

DISPOSAL: Securely wrap original container in several layers of newspaper and discard in trash.
