Dear Ms. Schlekau:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. Two (2) copies of the finished labeling must be submitted prior to releasing the product for shipment. A stamped copy of the label is enclosed for your records.

1. Based on the acute toxicity profile for this product revise the first part of the hazards to humans and domestic animals to read:

"Causes skin irritation. Do not get on skin or clothing. Wear coveralls worn over short-sleeved shirt and short pants, socks and chemical resistant foot wear and gloves (such as nitrile or butyl). Prolonged or frequently repeated skin contact  
xxxx etc."

2. Add "and other aquatic organisms" to the first sentence under Environmental Hazards.

Note, based on the acute toxicity of your product, you are not required to have an If in eyes nor If inhaled first aid statement. You may delete these statements if you wish.
