

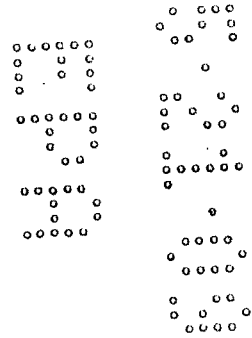
Enclosed are two (2) copies of the label. One (1) copy has changes highlighted.
