On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger, or if available by administering syrup of ipecac. If person is unconscious, do not give anything by mouth and do not induce vomiting.

d. In the enviromental hazard section, beginning with the first sentence, add the word "highly" after these statement "This pesticide is."

e. Under the directions for use, revise the end-use product formulation section to read "This product is to be used only to formulate insecticide products for domestic indoor use."

f. Expand the second sentence for "If On Skin" to "Get Medical Attention If symptoms occur or irritation persists."

2. The acute toxicity data profile for multicide Intermediate 2738 (EPA Registration Number 1021-1682) is being used to support the registration of this product. refer to EPA Registration Number 1021-1682 for the acute Toxicity data profile.

3. Submit three (3) copies of your final printed labeling before you release the product for shipment.
