DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Do not use in commercial food/feed handling establishments, restaurants, or other areas/sites where food/feed is commercially prepared or processed. In the home all food processing surfaces and utensils should be covered during treatment or thoroughly washed before use. Exposed food should be covered or removed.

Use this product to control: Fleas, Ants, Cockroaches (Palmetto Bugs, Waterbugs), Crickets, Yellow Jackets, Ticks, Flies, Spiders, Mosquitoes, Confused Flour Beetles, Carpet Beetles, Small Flying Moths, Saw-toothed Grain Beetles, and Rice Weevils.

GENERAL INFORMATION: Cover exposed food, dishes, utensils, and food handling equipment. Open cabinets, drawers, and doors in area to be treated. Close windows and outside doors. Use one unit for 6,000 cubic feet of unobstructed space. IMPORTANT: Do not remain in the building during treatment and ventilate thoroughly for 30 minutes before reoccupying treated area. Do not use this product in a cabinet or under a counter or table. Remove all pets, birds, and cover fish aquariums before using this product.

DO NOT use more than one fogger per room. DO NOT use in small, enclosed spaces such as closets, cabinets or under counters or tables. Do not use in a room 5 ft. x 5 ft. or smaller; instead, allow fog to enter from other rooms. *Turn off ALL ignition sources such as pilot lights (shut off gas valves), other open flames or running electrical appliances that cycle off and on (i.e., refrigerators, thermostats, etc.).* Call your gas utility or management company if you need assistance with your pilot lights.

SHAKE WELL AND KEEP CONTAINER UPRIGHT

FOR TOTAL RELEASE OF PRODUCT: TO OPERATE VALVE: To lock valve in the open position for automatic discharge, break off and remove tab on the side of the sprayer. Tilt sprayer away from face (container sprays straight up). Press down firmly on sprayer pad until it snaps into place. Place can on chair or table near the center of the area to be treated and leave the area at once. Keep out of the treated area for two hours and then ventilate as instructed above.

FOR FLEAS AND TICKS: Remove pet bedding before treatment. After treatment, replace pet bedding with new or freshly laundered bedding material. Pets should be treated with a pesticide product registered for use on animals at the same time that the house and yard are treated.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage and disposal.

STORAGE: Pesticide Storage

Store in a cool, dry placearea. Keep container closed. Always store pesticides in the original container. Store away from food and pet food.

DISPOSAL: Pesticide Disposal and Container Handling
