Only for use in and around residential areas such as Rooms, Apartments, Homes, Attics, Basements, Campers, Boats, Household Storage Areas, Garages, Pet Sleeping Areas, and Cabins.

SHAKE WELL BEFORE USE.

Use Information: Use this spray as a spot or crack and crevice treatment to control Asian lady beetles, Boxelder bugs, Brown Marmorated stink bugs (BMSB), cockroaches, fleas, silverfish, stink bugs, ticks, Waterbugs, and other insects listed below. Apply this product only as a coarse spray or crack and crevice treatment to localized areas where pests are found or may occur. Spray surfaces until wet.

FOR SPOT TREATMENT:

To kill Ants, Asian Lady Bird Beetles, Banded Garden Spiders, Black Widow Spiders, Bold Jumping Spiders, Boxelder Bugs, Brown Marmorated Stink Bugs (BMSB), Bud Spiders, Burrowing Wolf Spiders, Carpet Beetles, Cat face Spiders, Centipedes, Cigarette Beetles, Cobweb Weaver Spiders, Cockroaches, Common House Spiders, Confused Flour Beetles, Crickets, Cupboard Spiders, Daddy-Long-Legs, European House Spiders, Funnel Web Spiders, Giant Wolf Spiders, Grass Spiders, Ground Spiders, Indian Meal Moths, Marbled Cellar Spiders, Parson Spiders, Rice Weevils, Sawtoothed Grain Beetles, Scorpions, Silverfish, Southern House Spiders, Sowbugs, Spiders, Woodlouse Spiders, Stink Bugs, and Yellow Sac Spiders: Spray areas where these insects are found or may hide, including dark corners of rooms and closets; cracks and crevices in walls; along baseboards and door and window frames; behind and beneath sinks, stoves, refrigerators, and cabinets; and around garbage cans, plumbing, and other utility installations. Pests driven out of hiding places should be sprayed directly. For ants, spray ant trails and around doors and windows, and wherever else these pests may find entrance. For control of Black Carpet Beetles, spray along baseboards and edges of carpeting, under carpeting, rugs, and furniture and wherever these insects are seen or suspected.

To kill Brown Dog Ticks and Fleas: Thoroughly apply as a spot treatment to infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames, and localized areas of floor and floor coverings where these pests may be present. Pet's old bedding should be removed and replaced with clean, fresh bedding after treatment. **DO NOT SPRAY PETS WITH THIS PRODUCT.** Pets should be treated with a registered flea and tick control product prior to reentering treated areas.

FOR CRACK AND CREVICE TREATMENT:

To kill Ants, Asian Lady Beetles, Banded Garden Spiders, Black Widow Spiders, Bold Jumping Spiders, Boxelder Bugs, Brown Dog Ticks, Brown Marmorated Stink Bugs (BMSB), Bud Spiders, Burrowing Wolf Spiders, Carpet Beetles, Cat face Spiders, Cobweb Weaver Spiders, Cockroaches, Common House Spiders, Crickets, Cupboard Spiders, Daddy-Long-Legs, European House Spiders, Fleas, Funnel Web Spiders, Giant Wolf Spiders, Grass Spiders, Ground Spiders, Marbled Cellar Spiders, Parson Spiders, Scorpions, Silverfish, Southern House Spiders, Sowbugs, Spiders, Stink Bugs, Woodlouse Spiders, and Yellow Sac Spiders: Apply spray in small amounts directly into cracks and crevices. Equipment capable of delivering a pin stream should be used in points between different interior elements of construction, between equipment and floors, openings leading to voids and hollow spaces in interior walls, equipment legs and bases where these insects hide.

Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air. Avoid contamination of food or food handling surfaces.

Flies and Mosquitoes: Use only outdoors as an aid in reducing annoyance from these insects. Apply as spot treatments to outside surfaces of window and door frames as well as other areas where these pests may enter the home. Also apply as spot treatments to dark corners and localized resting areas (such as under eaves) or porches, patios, and garages where these insects may congregate. Flies and mosquitoes coming to rest on treated surfaces will be killed.

[Alternate use directions when using the product as an outdoor spray equipped with streaming spray button and extension tube]

[READ ALL DIRECTIONS COMPLETELY BEFORE USE] [Product name] is intended to use as a limited exterior spot treatment on residential structures to keep ants from entering the structure. Direct your application to areas that ants and other listed insects use as common entry points into residential structures. This product is especially useful in early spring when ants emerge and attempt to enter the house. Use it again in the fall when ants attempt to come inside for the winter.

SHAKE WELL BEFORE EACH USE. HOLD CONTAINER UPRIGHT. APPLY IN SHORT BURSTS and always use the attached red extension tube to direct the application. A spare red extension tube is included with each can. For best results, follow directions for specific listed insects and use areas. This product is designed for limited outdoor applications to building surfaces and spot treatments on structures only. Do not apply this product directly to animals. Any liquid may adversely affect some building materials. Always test in an inconspicuous area prior to widespread use.

DO NOT CONTAMINATE FOOD AREAS.

LIMITED OUTDOOR USE: All residential outdoor applications must be limited to building surfaces and spot treatments on structures only. Spray with caution when wind conditions may create a mist that may blow back to applicator. Always attempt to use the attached red extension tube or the spare. When engaged, spray will shoot out a stream 10 to 15 feet long. The liquid will expand upon hitting a target surface and then leave an invisible residual deposit to kill ants. Do not spray this product in and around bodies of water

ANTS: Focus your spot treatments to key areas outside the house, where you suspect ants are entering the structure, such as around downspouts and gutters, near window sills, and door openings. Seal up any visible exterior cracks where ants can be seen entering the home.

SPIDERS: Focus your spot treatments to spiders and webs on the exterior of building surfaces.

CRAWLING INSECTS: Cockroaches, Crickets, Sowbugs, Multicolored Asian Ladybird Beetles. Focus your spot treatments to key areas outside the house where you suspect these insects are entering the structure, such as around downspouts and gutters, near windowsills and door openings. Spray insects directly where possible. Seal up any visible exterior cracks where crawling insects can be seen entering the home.]

STORAGE AND DISPOSAL
