The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comment below. Two copies of the finished labeling must be submitted prior to releasing the product for shipment. A stamped copy of the label is enclosed for your records.

1. Delete the statement "This product may pose an aspiration pneumonia hazard" from the Note to Physician. This statement was required by EPA in error, based on our incorrect determination that the product contained petroleum distillates. Since it does not, you should delete the statement.
